Level of service offered

TENANT FIND FEES

£750 plus vat (£900 inc vat) for rentals up to £1000 PCM

£850 plus vat (£1020 inc vat) for rentals over £1000 PCM and up to £1250 PCM

£950 plus vat (£1140 inc vat) for rentals over £1250 PCM and up to £1500 PCM

£1050 plus vat (£1260 inc vat) for rentals over £1500 PCM

INCLUDES:
